1. **BACKGROUND**

The County has \$912,017.00 in unencumbered Program Open Space funds to allocate for FY2023. The County has also received \$1,000,000.00 in FY2023 Local Parks and Playgrounds Infrastructure Funding. The Program Open Space Committee received requests for 25 eligible projects totaling \$2,088,659.00.

2. **ISSUES**

The POS Committee met to review the requests and developed the POS Annual Plan for recommendation to the Commissioners. The plan includes funding 16 projects using the \$1,000,000.00 in FY2023 Local Parks and Playgrounds Infrastructure Funding. This funding does not require the Local Sponsors to have a 10% match, however based on the number of requests, we are recommending the local jurisdictions provide a 10% match for their projects and we recommend reducing the project scope for Piney Plains Community Park to meet the available funding. The total for the 16 projects is \$965,715.60. The remaining balance of \$34,284.40 will cover any small project overruns. The committee recommended that the remaining 9 projects use the POS FY2023 funds. These projects require a 10% match from the Local Sponsor. The total for these 9 projects is \$880,920.00. The remaining balance of \$31,097.00 will be used for property acquisition. There is also \$59,882.25 in acquisition funds available through Program Open Space. The POS Committee recommended that the available acquisition money be used to purchase the property for the Prichard Farms Community Park and to acquire the Maryland Avenue Baseball Fields located in the Town of Westernport. A request and recommendation summary is included with this staff report.

3. FINANCIAL IMPACT

Program Open Space funding is allocated to each County from the Department of Natural Resources for public recreation development and acquisition.
