If you have other family member(s) on the plan, each family member may need to meet their own individual deductible, OR all family members may combine to meet the overall family deductible before the plan begins to pay, depending upon plan coverage. <p>Are there services covered before you meet your deductible?</p>	<p>Yes, all In-Network preventive care services as well as the following (non-hospital facilities only, when applicable): Primary care, Specialist, Retail health, Diagnostic testing, Imaging, Prescription drug, Outpatient surgery, Emergency room, Emergency medical transportation, Urgent care, Inpatient services, Mental health services, Maternity services, Home health care, Rehabilitation services, Habilitation services, Skilled nursing care, Durable medical equipment, Hospice services.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. What is not included in the out-of-pocket limit ?	Premiums, balance-billing charges, health care this plan doesn't cover, copayments for certain services, and penalties for failure to obtain pre-authorization for services. Will you pay less if you use a network provider ?	Yes. See www.carefirst.com or call 855-258-6518 for a list of Network providers.	This plan uses a provider network . You will pay less if you use a provider in the plan's network .
