### 1. Purpose

The purpose of this policy is to establish a standardized Response Index System for all Fire and EMS Departments operating within Allegany County. This system ensures that each incident is assigned the correct response category and that all apparatus is dispatched in a consistent, predetermined order based on geographic box areas. From this point the 911 Joint Communications Center will be known as "Allegany".

### 2. Scope

This policy applies to:

- a) All Fire and EMS Departments dispatched by Allegany.
- b) All incident codes within Allegany's Computer Aided Dispatch (CAD) system.
- c) All box areas within Allegany County.

### 3. Incident Classification

Below are a list of incident types and the appropriate response categories that they will be dispatched.

### 4. Response Index Overview

- Each box area in Allegany County shall have one Response Index Card completed and filed with Allegany.
- The Response Index Card lists the order of responding apparatus for each category (Local, Rescue, Residential, and Commercial).
- Apparatus should be listed from closest to furthest, based on preferred unit response from each department.
- Areas where tankers are needed shall be clearly denoted on the index so that they can be properly programmed in CAD.



e. The Miscellaneous field may be used to add:

- 1) AIR Units
- 2) Rehab Units
- 3) Specialty Units (MP, etc.)
- 4) Please specify on which alarm these units are to be dispatched.

## 5. Unit Assignment Rules

- a. Double-pulling of units is not allowable until after the working alarm assignment.
- b. Response order should reflect closest to furthest apparatus to ensure the most efficient dispatch.
- c. Box Cards are drafted and submitted by the Fire-EMS Chief. Each greater alarm is based on these Box Cards. The filling of failed units is based on CAD's closest unit / type code.

## 6. Local Fire Response Levels

Local fires will be divided into two categories:

- a. Brush / Wildland Fires

Level	Response
Initial Response	First due company (brush unit(s), engine, tanker as applicable)
Level 1	+3 Brush Trucks, +3 UTVs, +2 Tankers
Level 2	+5 Brush Trucks, +3 UTVs, +1 Tanker, +1 Engine (fill site)
Level 3 & >	+5 Brush Trucks per level (additional specialty units as needed)

- 1) The IC may request higher levels based on fire growth or conditions
  - 2) Specialty units (e.g., DNR or Forestry units) may be added upon request.
- b. Local – Other Fires (Vehicle, Dumpster, Equipment, Etc.)

Level	Response
Initial Response	Company-level response (first due engine, tanker, and command)
Each Additional Response Upgrade	+3 Engines, +2 Tankers per level
Upgrades may be triggered automatically by IC or requested manually based on incident growth	

## 7. Residential, Commercial, and Rescue Assignments

Each box area's Response Index Card will include the desired apparatus for both Residential and Commercial fire assignments. The number and type of units per alarm will follow county-wide standards, unless otherwise authorized by the Standards Committee.

**Special Note:** The Automatic Fire Alarm Engines and Special should match the first two engines and special on your Commercial Downgrade for CAD programming purposes.

## 8. Programming and Updates

- a. Allegany will input all Response Index Cards into the CAD system as received and time permits.
- b. Departments must submit updated cards annually, or any time a unit assignment or response order changes.
- c. All cards shall be reviewed and approved by the Standards Committee during the meeting after box cards are received.

## 9. Compliance and Review

- a. Fire and EMS Chiefs are responsible for ensuring their department's information remains current.
- b. This policy shall be reviewed annually by Allegany County 911 Joint Communications Chief and Fire – EMS Chief's Chairperson to maintain operational accuracy.
